Konkretus tikslas	1 - Bendros vizų politikos rėmimas

Glaustai apibūdinti per finansinius metus įgyvendinant strategiją ir įgyvendinant nacionalinius tikslus padarytą pažangą.

The implementation of two national objectives foreseen in the programme has progressed as planned. **5 projects** under 4 actions (including SA) of the total value of 57.10% of the funds earmarked for SO1 were supported and carried out over the financial year. Following the procurement procedure, the final cost of some actions were lower than the one inicially programmed. The responsible authority reallocated the unspent amount among existing actions in order to optimiste the use of resources. All changes to the financial breakdown in the SO1, SO2 and SO3 of the basic ISF-B allocation at the national programme amounts of EUR 141,082.95 (0,57%).

The total number of projects planned to be implemented under SO1 is 9.

• NO1. National capacity

In order to ensure VISMAIL available and operational, VIS roll-out in the last set of regions, VIS is used for the issuance of Schengen visas and fingerprint verification at the border, technical and communication equipment upgrade at 20 key visa services, install and maintain point to point lines with the Embassies of the Republic of Lithuania and other consular offices (4 offices), increase flow of transmitted data as well, **3 projects** of the total value constituting 60.87% of NO1 funds were supported and carried out up to the date of this report.

• NO2. Union acquis

Seeking to improve the qualitative and quantitative performance indicators of Lithuania's visa services, a project "*Training for consular staff, Stage I*" of the total value constituting 50.00% of NO1 funds was supported and carried out up to the date of this report.

• **SA1:** Consular cooperation; Expansion of the representation at the Consulate-General of the RL in Almaty, Kazakhstan (1 project)

With effect of the implementation of the SA1 from March, 2017 Lithuania represents Iceland for the purpose of examining visa applications and issuing short stay Schengen visas in Almaty, Kazakhstan.

The duration of the all projects were laid down in the grant agreements. As a general rule the implementation of the projects is scheduled to last three years.

There are no threats that the projects might remain incomplete. All of the said projects will hopefully be implemented successfully in due time while achieving the results provided for in the programme.

No changes to the strategy are needed in view of the developments on the ground or developments in respective policy area on the national level over the past year.

Two actions were supported and carried out over the financial year:

• Implementation of the national VIS

The Information Technology and Communications Department (ITCD) has continued with the implementation of the project: *Adapting NVIS to changes in the Visa Code*. The ITCD has modernized the data model and the integration interface between N.VIS and C.VIS, the Aliens Registry Visa Module (modified visa application form, visa issuance logic and visa sticker printing), the Electronic Application Module, and created tools for working with N.VIS in "Offline" mode.

• Upgrading of technical and communication equipment of working places at visa services

The Ministry of Foreign Affairs has continued with the implementation of two projects:

Project: *Upgrading of technical and communications equipment of working places at visa services, Stage I.* The procured software and office equipment (desktop computers, monitors, scanners, ink-jet and laser printers and UPS units), anti-virus software, portable biometric enrolment equipment, virtual private network equipment will be distributed among 20 visa services. The 2 upgraded telephone exchanges and their peripheral equipment will be upgraded at the Consulate General of the Republic of Lithuania in Saint Petersburg an, the Consulate General of the Republic of Lithuania in Kaliningrad.

Project: *Procuring the leased line service*. Two international communications channels (leased lines) of 2 Mbps bandwidth are to be procured: the Ministry and the Embassy of the RL in the State of Israel; the Ministry and Embassy of the RL to the United States of America and the United Mexican States. The project is in line with the provisions of Regulation No 767/2008 of the European Parliament and of the Council concerning the Visa Information System (VIS) and the exchange of data between Member States on short-stay visas.

The total number of projects planned to be implemented within the programming period is 5.

The action supported and carried out over the financial year: Training for employees of visa services

The Ministry of Foreign Affairs has continued with the implementation of the project: *Training for employees of visa services, Stage I.* One course for consular officers (20 hrs.) and 2 regional training courses (28 hrs.) were arranged in 2017.

Training for Consular officers was conducted on terms: Review and implementation of the developments in the Visa Code; Local consular cooperation; Developments in the case law in examination of cases

according to complaints regarding refusal of issue visas/revocation of issued visas; Introduction to the functionality and tools of the VIS; Trends in document counterfeits and methods for identification; Problems related to the representation for other Schengen States when issuing Schengen visas.

Employees of visa services at regional training were trained on Issues of practical application of the Visa Code; Application of the simplification of the procedure for the issue of visas between the European Union and third countries; Problems related to the representation for other Schengen States when issuing Schengen visas; Communication with applicants, information of the public and the internal organisation of work.

As for training for consular officials, 26 staff members were trained in 2017. Regional training sessions for the staff of visa services in 2017 are to cover 29 staff members.

Stage II of the project will commence in 2019.

No funding priorities were planned under this national objective.

Konkretus veiksmas 1 - Konsulinis bendradarbiavimas

In order to to ensure the proper execution of the obligations assumed in representing four and more Schengen partners, thus contributing to the expansion of the very important and effective common EU visa policy area, which includes a better consular coverage and rational use of the available human and administrative resources, the Ministry of Foreign Affairs have continued with the implementation of a project "*Broadening of representation at the Consulate-General of the RL in Almaty, I stage*".

In accordance with this project, 1 consular officer position and 1 technical employee (filing clerk) were established and are maintained in the Consulate-General of Lithuania in Almaty starting 2016.

For the purpose of issuing Schengen visas the Consulate-General of the RL in Almaty represents Estonia (January 2012), Finland (May 2012), Sweden (June 2012), Norway (June 2015) and Iceland (March 2017).

Stage II of the project will commence in 2019.

The implementation of four national objectives foreseen in the programme has progressed as planned. **19 projects** under 11 actions (including SA) of the total value of 76.10% of the funds earmarked for SO2 were supported and carried out up to the date of this report.

In 2017 Lithuania awarded an additional amount of EUR 4,365,000 for the purchase of 1 coastal patrol vessel and 1 coastal patrol boat to be put at the disposal of the EBCGA.

The total number of the SO2 projects planned to be implemented in 2014–2020 is 27.

• NO1: EUROSUR

The 7 projects of the total value of 96.53% of the funds earmarked for NO1 intends to implement new and upgrade the existing border surveillance systems, enhance real-time exchange and cooperation between the NCC and other borders authorities. The projects include introducing 5 new local coordination centres and modernisation of the 1 regional and 8 local coordination centres at the RF and at Belarus borders. The projects contribute to reduce reaction time for border control, quality of analytical reports, as well as increasing of the NSP-level situational awareness.

• NO3: Common Union Standards

The **3 projects** of the total value of 83.00% of the funds earmarked for NO3 intends to introduce measures as are necessary to automatically verify the physical and electronic protection measures of travel documents with the set-up and operation of the technical infrastructure for the connection to the ICAO PKD, to harmonise voice radio communication network with Poland and Latvia as well as upgrade information system VRIS.

• NO4: Union Acquis - Borders

A project of the total value of 26.17% of the funds earmarked for NO4 intends to ensure the professional competences and skills of border guards and to increase the number of officers who are comprehensively prepared to participate in operations coordinated by the EBCGA.

• NO6: National capacity – Borders

The 7 projects of the total value of 90.42% of the funds earmarked for NO6 will ensure proper control and monitoring of the borders, taking into account the abolition of border checks at the internal border and strengthening of border checks and surveillance at the external border. It will be invested into modern, interoperable equipment, technical means for border control, as well as into strengthening the technical base for the risk analysis and crime intelligence. A secure IT based platform for the management of classified information on the external border management will enable faster data transfer and dissemination of criminal intelligence information; improve border guard contribution to Europol's SOCTA.

There are no threats that the projects might remain incomplete. All of the said projects will hopefully be implemented successfully in due time while achieving the results provided for in the programme.

No changes to the strategy are needed in view of the developments on the ground or developments in respective policy area on the national level over the past year.

The 2 actions supported and carried out over the financial year:

• Strengthen exchange of information among all the authorities responsible for external border surveillance by obtaining advanced electronic data processing and transmission techniques in order to maintain the National Situational Picture

Project: To procure and modernise hardware for continuous information exchange. The National Situational Picture will be maintain with information on the status and the position of available assets, areas of operation and information on environmental conditions at the external border, all incidents related to illegal migration, cross-border crime, crisis situations as well as analytical reports, risk rating trends, regional monitoring.

• Development of national border surveillance system (6 out of 7 projects).

The State Border Guard Services has continued with the implementation of the 4 projects:

A project LT/2017/PR/2121 - Installation of border surveillance systems was completed in December 2017. The border surveillance systems at the most vulnerable 5 border sections with Belarus controlled by the *Purvėnai*, *Druskininkai*, *Tribonys*, *Švenčionys and Pavoverės Frontier Stations* 180.44 km in length have been installed.

Project: Upgrading of border surveillance systems at Bardinai, Viešvilė, Lavoriškės, Žagunis Frontier Stations. The previously installed land border surveillance systems at the border with the Russian Federation (57.5 km) and at the border with Belarus (33 km) will be upgraded. A part of the project - border surveillance system at Bardinai FS are already upgraded.

Project: Upgrading of the maritime border monitoring system, Stage I. The maritime border surveillance system (119.6 km) will be upgraded. A public contract was signed on 3 October 2017.

Project: Upgrading of the border surveillance system at Plaškiai Frontier Station. The previously installed land border surveillance system at the Plaskiai FS (24.5 km) will be upgraded. A public contract was signed on December 2017.

In addition, an appraisal of two projects "Upgrading of the maritime border monitoring system, stage II" and "Upgrading of the border surveillance system at Vileikiai Frontier Station" are finalised. The projects will be carried out from the 2nd quarter of 2018.

There are no threats that the projects might remain incomplete. All of the said projects will hopefully be implemented successfully in due time while achieving the results provided for in the Programme.

The 3 actions supported and carried out over the financial year:

• Implementation of the biometric data verification system, stage II (1 project)

The Personalization of Identity Documents Centre under the Ministry of Interior (ADIC) has continued with the implementation of the project: *Implementation of the infrastructure for the single point of contact (SPOC)*. The project **was completed** in December 2017. After completion, Lithuania has established SPOC infrastructure and national DV interface to fulfil the requirements of Commission decision C (2009) 7476 to have a robust communication infrastructure for regular inter-country communication covering DV certificate exchange. SPOC is in a testing phase. When completed, will ensure full-fledged Extended Access Control using Machine Readable Travel Documents (eMRTD) for passports, travel documents and residents permits. Competent authorities in the Member States will be granted access to Lithuania's eMRTD while relevant authorities in Lithuania will have access to biometric information stored in eMRTD of other Member States.

• Harmonisation of radio communication with Poland and Latvia through installation of the voice information communication networks integration equipment and 4 common (virtual) voice information exchange channels (1 project)

The ITCD has continued with the implementation of the project: *Modernisation of the SMRRT*, *implementation of the radio interfaces with Poland and Latvia*. Having established network connection, interfaces and virtual communication channels, the state authorities of Lithuania and Poland that are involved in border management will have a more efficient and secure way of communication.

• Upgrading of the main and the back-up centres of the information system VRIS (1 project)

The ITCD has continued with the implementation of the following project: *Upgrading of the main and the back-up data centres of the VRIS, Stage I.* The VRIS, based on joint information technology and telecommunications infrastructure, will be able to ensure stable data exchange among the national information systems and SIS, VIS, Foreigners Register and Interpol's database.

The total number of projects planned to be implemented within the programming period is 4.

There are no threats that the projects might remain incomplete. All of the said projects will hopefully be implemented successfully in due time while achieving the results provided for in the Programme.

An action supported and carried out over the financial year:

• Specialised and advanced training of border guards aimed to improve professional competences and skills

The SBGS has continued with the implementation of the project: Specialised and advanced training of border guards aimed to improve professional competences and skills, stage I

The purpose of the project is to ensure the professional competences and skills of border guards and to increase the number of officers who are comprehensively prepared to participate in operations coordinated by FRONTEX.

The following trainings were organized in 2017:

- o Foreign language courses (27 officials);
- o Dog handling of service dogs (30);
- o Trainings for drivers (42);
- o Practical training for the procedures relating to asylum seekers at the border (30);
- o Criminal intelligence and pre-trial investigations (52);
- o Skipper training (61);

Training activities are brought in line with the sectorial qualifications frameworks (SQF) for border guarding.

Training has been planned to be held in the service provider's premises. Travel and subsistence costs incurred by the participants are qualified as eligible direct projects costs.

The total number of projects planned to be implemented within the programming period is 3.

There are no threats that the projects might remain incomplete. All of the said projects will hopefully be implemented successfully in due time while achieving the results provided for in the Programme.

The 4 actions supported and carried out over the financial year:

• Implementation of the national SIS II (1 out of 2 foreseen projects)

The ITCD has continued with the implementation of the project: *Implementation of the national SIS II (NSIS)*. National registers, functionalities of the use of fingerprints in the NSIS as well as the transmission of biometric data to the CSIS will be developed.

• Upgrading of software and hardware

The SBGS has continued with the implementation of the project: *Upgrading of software and hardware for border guards*. Computers (206 units), SQL Server, fingerprint scanners (181 units) and document scanners (181 units) are going to be procured.

Acquisition of technical means for border control

The SBGS has continued with the implementation of the following 4 projects:

Project: *Procurement of portable thermal visors and other border surveillance tools*. Purchase of portable thermal visors (229 units), night-vision devices (231 units) and binoculars (200 units) are foressen.

Project: Procurement of vehicles.

The SBGS will procure the following patrol vehicles: large all-terrain vehicles (70 units), minivans (18 units), 4-wheel moto-cycles with trailers (4 units), 2 minivans and 2 trailers for dog transportation. The 2 trailers were procured in 2017.

Projects: Capacity building for dog handling, Stage I; Capacity building for dog handling, Stage II

In strengthening canine operations, it is sought to increase the number of detected state border infringements. Service dogs help to detect the State border trespassing and track the suspect trespassers, find evidence, individuals hiding in forests, buildings and vehicles, check passenger and freight vehicles when they cross BCPs. *Stage III* will start in 2019.

• Establishment of a secure IT based platform for the management of classified information on the external border management by obtaining modern technical tools, an installed information system and a secure data transmission network (1 project)

Project: Creation of the information technology platform

The Virtual Workplace Platform to be used by up to 105 users is to be created. The project procurement procedures were carried out in accordance with the Procedure for public procurement concerning intelligence-related activities. The tendering procedures were launched.

The total number of projects planned to be implemented within the programming period is 9.

The notice of Call for Proposals on Purchase of thermal vision vehicle was published by the State Border Guard Service (SBGS) on 18 January 2018. A price offered by the only one tenderer propose in its tender was EUR 638 000, than a budget of project consists of EUR 350 000. Due to the fact that the budget is too small and the SBGS do not have the opportunity to contribute, the SBGS will simplify the technical requirements – they would refused to acquire tracking radar and any other equipment. This one will be purchased under the ISF Borders NO6 action "Acquisition of technical means for border control". A new call for tender will be launched during the second half of year 2018.

Lithuania awarded an additional amount of EUR 4,365,000 for the purchase of 1 coastal patrol vessel (CPV) and 1 coastal patrol boat (CPB) to be put at the disposal of the European Border and Coast Guard Agency in 2017.

The responsible authority adopted a Decision to make a financial contribution to a project on the coastal patrol vessel on 18 June 2018.

A project application on the coastal patrol boat is examined by the delegated authority. The findings on the project application shall be provided before the end of September 2018.

Delivery planned: Coastal Patrol Boat: <u>second part of the year 2019</u>; Coastal Patrol Vessel: <u>second part of the year 2020</u>.

Technical Equipment Pool (TEP) entry date: Coastal Patrol Boat - <u>second part of the year 2019</u>; Coastal Patrol Vessel - second part of the year 2020.

The 60.79% of SO5 funds have been allocated to 31 projects under NO1, NO2, NO3 and NO4 up to the date of this report. The total number of projects planned to be implemented is 54.

Two new priorities (PNR and Information exchange / interoperability) under NO2 have been included in the national programme. The ISF Action Plan was complemented by those priorities and 4 new projects. One project appraisal is already completed.

• NO1: C - prevention and combating

Seeking to implement 2 EMPACT operational projects, improve capacity to prevent and combat cross-border and organised crime of 4 law enforcement authorities, to achieve at least 50% of forensic institutions' field of expertise to be accredited, to execute more effective financial investigations (based on SOCTA), strengthen inter-institutional and international cooperation combating illicit drug circulation and fight against corruption, to raise public awareness of corruption, **16 projects** of the total value constituting 64.63% of NO1 funds were supported and carried out up to the date of this report.

• NO2: C - exchange of information

In order to improve national infrastructures for habitoscopical data collection and analysis concerning international organised crime, improve system of collection of comparative crime statistics, created analytical measures based on data of the Register of Criminal Offences (RCO), of uninterruptable receipt (24/7) of Retained Data from electronic communications in public electronic communication networks, **5 projects** of the total value constituting 59.68% of NO2 funds were supported and carried out up to the date of this report.

• NO3: C - training

In order to strengthen the national training system by establishing new training facilities, which meet the requirements and standards of modern, properly equipped training institutions, upgrading of existing and development of new and more sufficient and EU based training programmes and capacity building for national police officers by linking their training and their career, **7 projects** of the total value constituting 47.26% of NO3 funds were supported and carried out up to the date of this report.

• NO4: C - Victim Support

In order to protect and support witness and victims of crime by modernisation of witness and victim protection centres (including physical security equipment, computers and other related technical measures) and improve the polygraph publication and press engineering systems (in order to create and print quality and safer documents), **3 projects** of the total value constituting 42.45% of NO4 funds were supported and carried out up to the date of this report.

No changes to the strategy are needed in view of the developments on the ground or developments in respective policy area on the national level over the past year.

There are no threats the projects might remain incomplete. All of the said projects will hopefully be implemented successfully in due time while achieving the results provided for in the Programme.

• Action: Capacity building for effective financial investigations and fight against corruption: creation of an inclusive data management platform for automated processing, analysis, storage and exchange of data about violations of the financial system, development of a criminal intelligence management system at the Special Investigation Service (STT), tools for the anti-corruption education

Beneficiaries have continued with the implementation of the 3 projects. One out of them, a project LT/2016/PR/5143 – *Tools for anti-corruption education, stage I* was completed. Within the framework of the project an educational anti-corruption comic book for schoolchildren, 5 educational anti-corruption videos, a free application for smartphones "Report to STT" were created and published.

The total number of projects planned to be implemented under SO5 NO1 is 25. There are no threats that the projects might remain incomplete.

During the 2017 financial year the ISF Monitoring Committee put forward recommendations to the RA at meetings and through decisions adopted in writing (written submissions).

The written decision-making procedures covered the following:

5 December 2016 (Minutes No 8):

Irregularity identified in implementing the STS project "Additional operational costs of the ITCD in 2014". (The RA established that irregularity and rectified it before including respective expenditure in the statement of expenditure submitted to the EC.

10 January 2017 (Minutes No 9):

- 1. Allocating additional funds to the STS project "Replacement of vehicles for border guards", respectively reducing the financing for the project "Procurement of hardware and software for border guards";
- 2. Allocating funds to STS project "Construction of hangars and renovation of garages" instead of the closed project "Renovation of PSS dog kennels";
- 3. Replacement of the SO6 project "Enhancing the capacities of deminers of the LPAOR "Aras", stage II" to the project LT//2017/PR/6111 Enhancing the capacities of the Lithuanian Police Anti-Terrorist Operations Unit "Aras" to carry out special, anti-terrorist and hostage release operations, stage I".

14 February 2017 (Minutes No 10):

- Draft payment request for the annual balance to the EC for 2017 financial year.
- Allocating additional funds to STS project "Additional operational costs of the PD in 2019-2021" respectively reducing the financing of the project in years 2016-2018.

21 April 2017 (Minutes No 12):

- Relocation of the funds provided for the cancelled STS action "Installation of video systems at Kaišiadorys, Naujoji Vilnia and Vievis Rail Stations" to the newly proposed action "Development of video surveillance systems along the Kena–Kybartai railway";
- Revision of the ISF programme due to additional amounts intended for the PNR and IT systems.

18 September 2017 (Minutes No 14):

• Allocating additional funds to SO5 projects respectively reducing the financing for other SO5 projects;

• Allocating additional funds to SO2 NO1 project "Upgrading of the maritime border monitoring system, Stage 1", respectively reducing the financing for the stage I of the project.

15 October 2017 (Minutes No 15):

• New actions and accordingly projects to be included in the Action Plan of the ISF programme under Policy Priorities: PNR; Information interoperability.

At meetings:

24 March 2017 (Minutes No 11)

• Approval of the draft implementation report ISF in 2017; Updates of the Action Plan on SO5 projects.

4 August 2017 (Minutes No 13):

• Allocating additional funds to 4 projects respectively reducing others. Relocation of the STS savings to the Foregone Visa Fees in 2016.

6.2. Bendra stebėsenos ir vertinimo sistema (Reglamento (ES) Nr. 514/2014 14 straipsnio 2 dalies f punktas)

Atsakingos institucijos nustatytos stebėsenos ir vertinimo priemonės, įskaitant duomenų rinkimo tvarką, vertinimo veiklą, kilusius sunkumus ir priemones, kurių buvo imtasi jiems išspręsti.

Responsible authority (RA) as well as delegated authority (DA) have monitored the ISF common indicators and programme specific indicators as well as other project results. According to project agreements, every project has an ISF programme indicator (if applicable) that is planned to achieve and project performance indicators. In accordance with a pre-agreed payment application submission schedule, project promoter submits payment applications to a delegated authority and reports on the project performance indicators set in a project agreement as well as ISF common indicators and programme specific indicators (if applicable). Indicators and their achievement are monitored through the ISF information system VORAS.

DA verifies payment applications while analysing project performance indicators provided in the payment application for the reporting period as well as ISF common indicator and programme specific indicator (if applicable). DA monitors the level of achievement of project performance indicators and ISF programme indicator (if applicable) while also considering indicator values provided in a project agreement. If the desired level of an ISF programme indicator and/or project performance indicator provided in a project agreement is not achieved, the delegated authority assesses the reasonableness of funding for such project, and can propose to reduce the funding to this project in accordance with the ISF programme's project administration and financing rules. There were no such problems in the 2017 financial year. Project providers implemented projects consistently and smoothly, so it is expected that in accordance with the submitted project provider's payment applications, all the planned project performance indicators and ISF programme indicators (if applicable) will be achieved at the end of the project's implementation.

Ensuring an overall monitoring system, on-the-spot controls are also carried out and can be organised by either RA or DA. In the 2017 financial year, both RA and DA organised project inspections and on-the-spot controls. On-the-spot control revealed that project provider ensure good progress of projects and control their implementation, provide orderly documentation and its storage.

ISF programme monitoring revealed good cooperation between the RA and DA and maintenance of direct control over the implemented projects. Following the beginning of the programme's implementation in the 2017 financial year, the RA and DA discussed the implementation progress of ISF programme projects, the absorption of funds, problems encountered and possible solutions.

The role of the ISF Monitoring Committee is very important in the monitoring process as it oversees all reports that are submitted to the European Commission, i.e. before its submission to the European Commission the annual balance payment application and annual implementation report for the 2017 financial year went through the coordination process.

On the website of the Ministry of the Interior the information is provided about approval of the ISF programmes annual accounts, the approval of the implementation reports, as well as the points of the ISF monitoring committee discuss and the process of the projects' implementation.

Beside this, promotional items compliant with the awareness rising requirements of the ISF were procured: developing of the ISF website, calendars, work books, etc.

The specific requirements and measures of information and visibility were laid down in the Internal Security Fund Visibility Guidelines. Final beneficiaries are responsible for informing on co-financing of the project activities from the Fund. The delegated authority was responsible for the supervision of the observance of the guidelines and conduct on-the-spot checks for that purpose at least once during the project (usually before the final payment). The components of the image of the Fund (logo, image plan, etc.) were applied consistently.

The ISF logo was displayed on all publications, guidelines and training materials financed from the ISF.

The Monitoring Committee include into its composition, as members or as observers, representatives of institutions responsible for the use of other related financial instruments. The participation of such representatives are specifically important at the meetings discussing issues related to the implementation of specific objectives.

Anti-corruption measures and training for the employees are complementary to the thematic objective 11 of the European Social Fund. The responsible authority analysed whether the activities set out in the project applications of the Special Investigation Service will supplement the 2015-2019 Inter-Institutional Action Plan for the Implementation of the National Anti-Corruption Programme for 2015-2025 approved by the Government of the Republic of Lithuania and whether it will not overlap with the measures funded from other EU sources provided for in the Action Plan.

6.6. Tiesioginis sutarčių sudarymas

The Fund intervenes in the areas where either *de jure* monopolies of national administrations exist or where security reasons exclude a possibility of an open call for proposals.

All beneficiaries (SBGS, Police Department, Ministry of Foreign Affairs, Public Security Service, etc.) of the EU funds are the only entities invested with the powers to carry out such activities, in which case a de jure or de facto a monopoly situation exists.

Actions under the ISF programme are implemented on the basis of a restricted call for proposals.
